1. Handicap will be 90% of 200.
2. Participants are required to use current book average as of April 15, 2006. If no book average is available, use Highest 2006 summer average of 21 games or more, or 2007 current 21 game average. In these two cases, verification must accompany the entry form. All others will bowl scratch in A Division.
3. Entries close midnight, Thursday, March 1, 2007 unless the limit is filled prior to that date. Check-in times are: Monday 8:45 AM and Sunday 10:00 AM. **No walk-ins or substitutes please.**
4. The ten pin provision of USBC Rule 319a -2 is hereby waived for this tournament.
5. USBC Rule 319d and 319e are hereby waived for this tournament.
6. USBC Rule 319a -3 will apply as to average of bowler.
7. Participant must be a member of a San Diego area 200 Club and a member of the USBC All others are excluded. Participants must present current 200 Club Card and current USBC Card when checking in.

8. Bowler will bowl three (3) games on a handicap basis in this tournament. Bowlers may enter only once.
9. Two places will be paid on first ten entries; one place for additional ten entries or major fraction thereof. All prize monies will be returned 100%.
10. Entry fee money cannot be returned. USBC Rule 314.
