(NOTE: Current PBA Touring members not eligible for tournament)

The San Diego Queens (Women) & Masters (Men) Tournament is open to all Bowlers in the SDUSBC. Multi-Members must have purchased a Multi-Member Card (USBC Rule 101) and be currently bowling in a league in the San Diego Assoc. with 21 games or more as of Tournament date, 2015. (No Cards will be sold on site.)

1. Contestants of the Queens & Masters Tournament may not practice on any of the tournament lanes prior to tournament starting.
2. Bowlers will be allowed ten (10) minutes of practice on their starting lanes.
3. USBC Rule 319d will be waived. (Winning)
4. The tournament champions will receive a paid entry into the 2015 SD USBC Queens & Masters Tournament.
5. Any entrant while participating, may be disqualified for any of the following reasons:
 - a. Any infraction of the rules.
 - b. Conduct derogatory to the best interest of the tournament.
 - c. Use of foreign substance which comes in contact with the approach or the lanes.
 - d. *Disqualification of entrant/no show* shall result in forfeiture of the entry fee and any right to prize money.
6. Optional Side Pots & Brackets.
7. Bowlers are responsible to be present at the beginning of the tournament. Should a bowler arrive after the official starting time, they will receive a **zero for each frame missed**.

PRIZE FUND BREAKDOWN will be determined by the # of entrants with 100% returned.

Playing Format

QUEENS *

QUALIFYING ROUND

Each bowler will bowl six (6) games across the required number of lanes moving 1 pair to your right after each game.

FINALS: There will be a cut to the top 6 bowlers * for the finals. **Round 1:** Bowl 1 game. 1st place will bowl 6th place. 2nd place will bowl 5th place. 3rd place will bowl 4th place. **Round 2:** High Score from each pair will advance. (Bowl one game.) Round 2 winners, two highest scores will advance to final round. **Round 3.** Final round winner is 2015 Queens Champion.

MASTERS *

QUALIFYING ROUND

Each bowler will bowl eight (8) games across the required number of lanes moving 1 pair to your right after each game.

FINALS: Top 8 bowlers will then bowl match play, the final round being a position round. Winner of each round shall be awarded 30 bonus points. The highest pin fall with awarded points is the 2015 Masters Champion.

In the event of a tie, a ninth (9<sup>th</sup>) and tenth (10<sup>th</sup>) frame will be bowled until the tie is broken. The extra frames will start on the same lane each contestant finished on. Contestant on the odd numbered lane will start first.

1. Lane assignments will be determined by the Tournament Committee.
2. Contestants on the odd numbered lane will start first.
3. After each match, bowlers will move to a different set of lanes

#### \*Dress Code

Collared, Mock Collared, Collarless t-shirt/sports type, dress shirts. Long pants or knee length walking shorts are permissible. Offensive attire, tank tops, or hats **NOT** permitted.

Any dress code questions or concerns will be addressed by the Chairman of the committee.

**NOTE: Equipment:**

The Tournament Manager will handle any Questionable circumstances.

**Equipment Alterations:**

Altering the surface of a bowling ball by the use of abrasives, cleaners or polish is prohibited during competition, in addition, no substance may be placed on the outer surface of the bowling ball. You are permitted to sand the surface of your bowling balls prior to certified competition, however, the use of abrasives is strictly prohibited once the first ball is thrown in competition. The outer surface of the bowling ball may only be cleaned with a dry towel once the bowler has begun competition. No modifications can be made to affect the balance of the bowling ball once competition has begun. (i.e. Additional weight holes, modification of existing holes, etc).

**NOTE:**

You cannot alter the surface of the bowling ball (including sanding) during competition.

Competition is defined as any time individuals are bowling for score.

- Penalty for the first offense...individual is warned and the ball is removed from that competition for the remainder of the series, match or block.
- Second offense...Disqualification from the remainder of the event in which the violation occurred.

**FOREIGN SUBSTANCE**

Also, no foreign substances can be applied to bowling shoes or approaches. This includes, but is not limited to: rosin, powder, Easy-Slide, dry bags, slide stone, soap stone, polish wax, alcohol and like products.

- Penalty for the first offense: Individual is warned.
- Second offense: Disqualification from the remainder of the event in which violation occurred.
