Multi-Members must have purchased a MultiMember Card(USBC Rule101) and be currently bowling in a league in the San Diego Assoc. with 21 games or more as of March 6 ${ }^{\text {th }}$, 2016(with league sheet for verification). No cards sold on site.

## 2. Entering Average Rules:

a. Entering average shall be the highest 2014-2015 San Diego Book Average of 21 or more games winter or summer whichever is highest. If no book or summer
b. Highest current average of 21 or more games (with league sheet for verification) as of March $6^{\text {th }}, 2016$
c. If none of the above the entering average will be 179 for men - 169 for women.
d. USBC Rule 319a-2 will apply, 319d is waived for this tournament.
e. Failure to use correct average will disqualify scores.

## 3. General Rules:

a. This is a three (3) game singles event, handicap basis will be $90 \%$ of 200 .
b. All prize monies will be returned $100 \%$. Pay-off will be one (1) out of every six (6) entries.
c. A bowler arriving late may bowl, score will begin in the frame currently being bowled.
d. In the event a bowler cannot finish their series, zero will be given for the remaining frames.
e. USBC Rules will govern this tournament. The decision of the tournament committee shall be final unless an appeal is made in accordance with USBC Rule $\mathbf{3 2 9}$.

## 4. Dress Code

a. Entrants are expected to wear appropriate attire
b. Examples of prohibited attire include but not limited to: Hats, tank tops, bare midriffs, spaghetti strap tops, workout attire, short-shorts, short skirts, bib overalls, jeans that are not in good condition, etc. c.
