San Diego USBC Open & Women City Tournament Rules

Eligibility:

- 1) Open to current 2016/2017 Winter league sanctioned bowlers of San Diego USBC bowling association jurisdiction with 21 gms more and as of January 1, 2017.
- 2) Multi-Members shall have purchased a Multi-Member card (USBC rule 101) and also be currently bowling in a 2016/2017 Winter league under SDUSBC jurisdiction with 21 or more games as of January 1, 2017. (no cards sold on site)

Entering Average:

- 1) Shall be highest sanctioned 2015/2016 book (including 2016 summer) of at least 21 gms or current winter league average of at least 21 gms as of Jan.1, 2017 whichever is verified highest.
- 2) If none of the above, average of 230 shall be assigned.
- 3) If you bowl in sanctioned standard leagues, the highest average shall be used. If you only have a sanctioned Sport/Challenge condition league average of 21 games or more, this average shall be adjusted according to USBC Rule Chart. If the bowler does not accept re-rated average, the entry fee shall be refunded.
- 4) USBC rule 319A-3 shall be applied and rule 319D shall be waived.

General Information & Rules:

- 1) Any NSF returned checks will cost \$35.00 service fee plus any additional bank charges.
- Bowlers shall not be entitled to refund after fees have been received and lane assignments issued by association. Exceptions shall be determined by Tournament Manager.
- 3) The Tournament Manager may refuse entry to any individual from participating if determined that the entry does not meet membership or tournament requirements.
- 4) In the event a bowler is tardy, may still participate starting in the frame currently being bowled, however shall receive "zero" score for each frame missed.
- 5) In the event a bowler cannot continue tournament play due an injury or illness & no substitute is available, shall receive "zero" score for each frame missed.
- 6) Line-up changes shall not be permitted once entry has been submitted, squad times, and lanes have been assigned by Tournament Manager.
- 7) Entrants may participate up to 3 times in team event. No more than 2 bowlers on 1 team may place more than once in the prize list for position standings. (see USBC rule 315B-1) Open bowlers may participate only once in doubles & singles. Women bowlers may participate only once in doubles & singles.
- 8) Bowlers who participate on more than 1 team, the first series bowled shall be used for All Events.
- 9) Two (2) Pro-bowlers per team and one (1) per doubles team is permitted.
- 10) Handicap is based on 90% of 230 scratch.
- 11) No practice is permitted on your scheduled lanes the day of tournament.
- 12) **Substitutions:** Are permitted in each event (team/doubles/singles) and shall bowl in same position as person replaced. Any monetary arrangements are agreed between original event bowler and substitute with written copy to Tournament Manager. If possible, changes can be made at SDUSBC office prior to entry closing date or at check-in which is 1 hour before squad start time. NO PACERS ALLOWED.
- 13) **Scheduling:** Tournament Manager shall schedule squad times requested on entry if possible. If necessary, due to lack of entries or too few requests for specific squad time, may be changed to different squad/day and team caption shall be notified.
- 14) All Events: This is optional & must be paid before entry closing date. Exceptions shall be addressed by Tournament Manager.
- 15) Awards: Team Champions (4), Doubles Champions (2), Singles Champion (1), & All Events Champion (1) for Open & Woman (16).
- 16) Prize Money: Shall be 100% returned and distributed as follows; Team/Doubles/Singles (1) for every (7) entries, All Events (1) for every (15).
- 17) Shall remain on same pair of lanes for both doubles & singles.
- 18) Equipment: Altering the surface of bowling balls using abrasives, cleaner, or polish is prohibited once competition has started. The outer surface may only be cleaned with dry towel. Also, no modifications allowed that may affect bowling ball balance, such as weight, or existing finger/thumb holes. In addition, Rule 18/3, is in place that prohibits equipment modification between Doubles and Singles events.

 Penalty; First offence, bowler is warned and ball removed from that particular event. Second offence is disqualification from event.
- 19) Approach Foreign Substance: No foreign substance is permitted to be applied to bowling shoes or approaches. This includes, but not limited to; powder, rosin, easy slide, soap/slide stone, polish wax, and like products. Any questions/concerns contact Tournament Manager. Penalty; First offence, bowler is warned. Second offence is disqualification from event.

Protests: USBC Rule 329; Any protest affecting eligibility or general rules, <u>must</u> be submitted in writing to the Association Manager before awards & prize monies are distributed. The Association Board of Directors shall have authority to act on all protests. The Tournament Committee shall have authority to act on all matters pertaining to the tournament. Appeals from the Tournament Committee decision shall be filed in writing to the National USBC Arlington Texas also prior to awards & prize monies are distributed. The decision of National USBC is final and binding.

Dress Code:

1) Collared, Mock-collard, collarless sports type t-shirt, dress shirts shall be permitted. Long pants, knee length walking shorts (as measured while standing upright) are also permissible. Unacceptable attire examples; Hats, tank/halter/spaghetti string tops, bare midriff, short-shorts, bib overalls, & jeans that are not neat or torn. Any dress code questions/concerns shall be addressed by Tournament Manager.
