The San Diego Queens (Women) & Masters (Men) Tournament is open to all Bowlers in the SDUSBC. <u>Multi-Members</u> must have purchased a Multi-Member Card (USBC Rule 101) and be <u>currently</u> bowling in a league in the San Diego Assoc. With 21 games or more as of February 28, 2013. (No Cards will be sold on site.)

- Contestants of the Queens & Masters Tournament may not practice on any of the tournament lanes prior to tournament starting.
- 2. Bowlers will be allowed ten (10) minutes of practice on their starting lanes.
- USBC Rule 319d will be waived.
- 4. The tournament champions will receive a paid entry into the 2014 SD USBC Queens & Masters Tournament.
- 5. Any entrant while participating, may be disqualified for any of the following reasons:
 - a. Any infraction of the rules.
 - b. Conduct derogatory to the best interest of the tournament.
 - Use of foreign substance which comes in contact with the approach or the lanes.
- 6. Disqualification of entrant shall result in forfeiture of the entry fee and any right to prize money.
- Optional Side Pots.
- B. Bowlers are responsible to be present at the beginning of the tournament. Should a bowler arrive after the official starting time, they will receive a <u>zero for each frame missed</u>.

Playing Format

QUEENS

QUALIFYING ROUND

Each bowler will bowl six (6) games across the required number of lanes moving to your right after each game. Lane assignment will be determined by the Tournament committee.

FINALS: There will be a cut to the top 6 bowlers * for the finals. Round
1: Bowl 1 game. 1st place will bowl 6th place. 2nd place will bowl
5th place 3th place will bowl 4th place. 3 top bowlers will advance.
Round 2: Bowl one game. Two top bowlers will advance to final round. Round 3. Final round winner is 2013 Queens Champion.

After each match, bowlers will move to a different set of lanes.

* In the event of a tie for the last qualifying position, one (1) complete game will be bowled immediately. If a tie still exists at the end of game, a ninth (9th) and tenth (10th) frame will be bowled until the tie is broken. The extra frames will start on the same lane each contestant finished on. Contestant on the odd numbered lane will start first. This rule shall apply throughout the tournament whenever applicable.

MASTERS

QUALIFYING ROUND

Each bowler will bowl eight (8) games across the required number of lanes moving to your right after each game. Laneassignment will be determined by the Tournament committee

FINALS: There will be a cut to the top 6 bowlers * for the finals. Round 1: Bowl 1 game. 1st place will bowl 6th place. 2nd place will bowl 5th place 3rd place will bowl 4th place. 3 top bowlers will advance. **Round 2:** Bowl one game. Two top bowlers will advance to final round. **Round 3.** Final round winner is 2013 Masters Champion.

After each match, bowlers will move to a different set of lanes.

Dress Code

Collared, Mock Collared, Collarless t-shirt/sports type, dress shirts. Long pants or kneelength walking shorts are permissible. Offensive attire, tank tops, or hats NOT permitted. Any dress code questions or concerns will be addressed by the Chairman of the committee.
