# TOURNAMENT INFORMATION • PLEASE READ CAREFULLY

## ENTRY CLOSING DATE IS FEBRUARY 20, 2007

Members may enter and bowl in each event of the tournament **ONE TIME ONLY**. Teams must have four women listed, and Doubles must have two women listed. Those entering doubles must also enter singles and vice versa.

**ELIGIBILITY:** Each entrant must be a female member in good standing in USBC and a California Certified League.

**FEES:** REMIT BY BANK/PO money order, certified check, sponsor's check or personal check made payable to **California USBC Association**. A \$25.00 charge will be assessed for a returned check. No more than two checks or money orders will be accepted for any one entry. Overpayment of four dollars and less is not refunded. Fees are refundable only when the USBC office is notified, in writing, within 15 days of the schedule notice mailing date, that the date and time assigned is not acceptable.

**AVERAGE:** All averages must be established in a USBC Certified league. . Less than 21 games or composite average are not eligible. **THE CAPTAIN IS RESPONSIBLE TO USE THE HIGHEST KNOWN AVERAGE**, whether established as a regular team member, or as a league substitute. Required verifications must accompany the entry.

**Use the averages in the order given below, and as the average applies to each bowler.**

1. **Official Average:** (Book Average) The highest known average for the winter season 2005-2006 which was taken April 15, 2006. If none, then use No. 2.
2. **2006 Summer League Final Average:** This average must be verified in writing by the Local Association Office Only, giving the total number of games bowled and the date the average was established. If none, then use No. 3.

3. **Winter League Average** for the Current season (2006-2007). This is the highest known average for the total number of games bowled as of April 15, 2007. **THIS AVERAGE MUST BE VERIFIED IN WRITING BY THE LOCAL ASSOCIATION OFFICE ONLY**, which will give the total number of games bowled and the date the average was established.

**A MEMBER NOT HAVING COMPLETED THE REQUIRED NUMBER OF GAMES TO ENTER A CLASSIFIED DIVISION SHALL BE ASSIGNED AN AVERAGE OF 200.** Information on averages to use for replacement bowlers (substitutes) will be included in the confirmation mailing.

**SCHEDULE INFORMATION:** The compiled schedule is changed only for an extreme emergency and only when possible.

List the date you prefer. Entries complete with all required information, verifications and correct fees, will be assigned a date according to receipt in the CWBA office. Bowling will be scheduled on Saturday days and nights, Sunday days. There will be bowling on all Holidays falling within the tournament schedule. **BE SURE YOU USE A 2007 CALENDAR.**

Teams wishing to bowl together on a pair of lanes must make the request in writing, and the entries must be mailed in the same envelope. Teams requiring the same dates and times, **MUST** list dates so as to correspond with all teams involved, and **MUST** be mailed in one envelope. **Entrants in doubles and singles only are required to accept dates and squad times when lanes are available.**

**Please use the Team Section to submit information needed for doubles and singles Only.**

**HOUSING:** Information for hotels and motels is enclosed with the schedule notice forwarded to the team captain. Bowlers will arrange for their housing with the hotel or motel of their choice.
