SAN DIEGO USBC CITY CHAMPIONSHIPS TOURNAMENT RULES

ELIGIBILITY: - Current members of the San Diego USBC Bowling Association are eligible to participate in this Annual Championship Tournament. Membership card must be shown.

ENTRY FEE: \$18.00 per event. Team / Doubles / Singles + 6.00 for All Events for a total of \$60.00 per bowler.

(\$6.75 Lineage, \$1.25 Expenses, \$10.00 Prize Fund - \$18.00 per person/per event)

HANDICAP: 90% OF 230 SCRATCH. Team - 920, Doubles - 460, Singles - 230.

ENTERING AVERAGE RULES:

- 1. Entering average shall be the highest 2005-2006 Book average of 21 or more games. If no book
- 2. 2006 highest Summer League average of 21 or more games subject to verification and approval.
- 3. Highest current average as of January 1, 2007 of 21 or more games or more
- 4. If none of the above the entering average will be 230.
- 5. If your January 1st average of 21 games or more is 10 pins or more higher than your 2005/2006 book or your highest 2006 Summer average, you must use your highest January 1st average.
- 6. SEE RULE (319a 2, 3 & 4). Rule 319 D is waived for this tournament.

GENERAL INFORMATION AND RULES: – Bowlers must dress neatly. No tank tops, sleeveless shirts or hats permitted. No bowler may change the position in any lineup after the entry has been accepted and scheduled by the Tournament Manager. Bowler may participate ONLY ONCE IN THE DOUBLES AND SINGLES EVENTS. Bowlers may compete with more than one team under the following conditions: SEE RULE (315b).

- (1) Only two (2) members already entered in the tournament may bowl together on another team.
- (2) When a bowler is a member of more than one team, (maximum of three) the FIRST SCORE bowled in team event shall count for the ALL-EVENTS.
- (3) In the event a bowler is late, or does not show up, the team receives zero for the frames missed, but may compete the game being bowled. If a bowler cannot continue due to an injury and no replacement is available, the team receives zero for that bowler.
- (4) No team or individual shall be entitled to a refund of any kind after the fees have been received at the tournament office and a definite schedule date has been assigned.
- (5) The Tournament Manager may refuse any team or individual to bowl if it is determined that the entry does not meet the membership and tournament requirements.

Practice will not be allowed on your scheduled lanes on the day of the tournament.

CHECK IN TIME: - TEAM, SINGLES & DOUBLES will check in one half (1/2) hour before scheduled time to bowl.

LEAGUE RESERVATIONS: - accepted only when accompanied by the Full Entry Fees for each team in the league.

SUBSTITUTIONS: – will be allowed in each event. (Team – Singles & Doubles). There will be no changes in the original line-up. If a substitute is used, they will bowl in the position of the bowler being replaced. Any monetary or prize arrangements should be made with the original entrant and the substitute before the event(s) is/are bowled. Substitutions can be made at the SDUSBC office prior to the closing date of entries, or at the tournament site prior to the scheduled event.

PENALTY FOR RULES VIOLATIONS: – A Person who bowls in this tournament and commits an infraction of the rules - bowls under an assumed name, not their highest average, or is under suspension, shall forfeit all awards or prize money and shall be disqualified from further competition in the tournament. Such a person or persons shall also be subject to suspension from USBC.

REQUESTED SQUAD TIMES: – If Tournament Manager deems it necessary due to lack of entries, bowlers may be changed to a different date or squad. Captain will be notified of any change.

ALL EVENTS: -Participation in the All-Events is OPTIONAL. The \$6.00 entry fee will be returned 100% in a ratio of one (1) prize for every (10) entries. There will be a ratio of (1) prize for every (6) entries in the Team, Singles & Doubles Events. All prize money returned 100%.

AWARDS: Team(4) Doubles(2) Singles(1) All Events(1)

THE TOURNAMENT MANAGER – Will schedule bowlers at the times requested, if those times are available. The tournament committee will decide on all matters pertaining to the tournament. Appeals from the Tournament Committee decision must be filed in writing to the San Diego USBC Board of Directors prior to the payment of prizes. The decision of the United States Bowling Congress is final and binding.

AVERAGE RERATE AND ADJUSTMENT: – Tournament management reserves the right to re-rate any bowler prior to bowling in the tournament. The City Tournament Average of the past three years may be used for re-rating. If the bowler does not accept the re-rated average, the entry fees will be refunded.
