## Prince and Princess Tournament Rules

- 1. **ELIGIBILITY:** Current members of the San Diego USBC Bowling Association are eligible to participate in this tournament. Membership card must be shown. <u>Multi-Members</u> must have purchased a Multi-Member Card (USBC Rule 101) and be <u>currently</u> bowling in a league in the San Diego Assoc. With 21 games or more as of April 15, 2011. (No Cards will be sold on site.)
  - A. ENTERING AVERAGE RULES:

Name:

- 1. Entering average shall be the highest 2010-2011 Book average of 21 or more games. If no book
- 2. 2011 highest Summer League final average of 21 or more games with verification. If none \*\*
- 3. Highest current average of 21 or more games as of March 9, 2012.
- 4. If none of the above the entering average will be 175 men 169 women.
- 5. If your current average of 21 games or more as of March 9, 2012 is ten pins higher than your 2010/2011 book, you must use your highest average.
  - \*\* League sheet must accompany entry.
- B. USBC Rule 319-c: The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee will be refunded.
- C. Failure to use correct average will disqualify scores.
- D. USBC Rule 319-a 3 will apply. USBC Rule 319-d and e will be waived,
- 2. This is a three (3) game singles event, handicap basis will be 90% of 200.
- 3. All prize monies will be returned 100%. Pay-off will be one (1) out of every six (6) entries.
- A bowler arriving late may bowl, but their score will begin in the frame currently being bowled.
- 5. In the event a bowler cannot finish their series, zero will be given for the remaining frames.
- 6. USBC Rules will govern this tournament. The decision of the tournament committee shall be final unless an appeal is made in accordance with USBC Rule 329.

## **Dress Code**

Collared, mock collared, collarless t-shirt/sports type, dress shirts. Long Pants or knee length walking shorts are permissible. Offensive attire, tank tops, or hats NOT permitted. Any dress code questions or concerns will be addressed by the Chairman of the committee.
