## SAN DIEGO USBC SENIOR MEN'S MASTERS AMATEUR 2011 TOURNAMENT GENERAL PLAYING RULES

- 1. Open to all senior men (50 and over) as of the tournament date with a valid SAN DIEGO USBC Association sanction card and bowling in a league with 21 games or more. Any bowler who is currently and/or actively participating in a national professional tournament will be ineligible to participate in this tournament. <u>Multi-Members</u> must have paid local association fees(\$9.00), and be currently bowling in a league in San Diego with 21 games or more.
- 2. Check in will be **One Hour** prior to scheduled time of bowling.
- 3. Bowlers are responsible to be present at the beginning of the tournament. should a bowler arrive after the official starting time, they will receive a zero for each frame missed.
- **4.** Qualifying Round: will consist of six(6) games bowled moving one pair of lanes after each game. **Ties**: a 10<sup>th</sup> frame will be bowled to determine the winner. If a tie still exists, an additional 10<sup>th</sup> frame will be bowled until tie is broken. Step Ladder cut will be top 5 qualifiers.
- 5. THERE WILL BE NO CARRY OVER OF PINS TO THE FINAL ROUND.
- **6. FINALS:** Top **5** Qualifiers bowl step ladder format. After each game move one(1) pair of lanes. **Ties**: a 10<sup>th</sup> frame will be bowled to determine the winner of that match. If a tie still exists, an additional 10<sup>th</sup> frame will be bowled until tie is broken.
- 7. USBC rule 319d will be waived.
- 8. No payoff at tournament site. Payoff will be within 30 days of tournament.
- **9.** Tournament Committee shall decide any and all disputes. Their decision is final unless an appeal is made in accordance with USBC Rule 329.
- **10.** Any entrant while participating, may be disqualified for any of the following reasons:
  - a. Any infraction of the rules.
  - b. Conduct derogatory to the best interest of the tournament.
  - c. Use of foreign substance which comes in contact with the approach or the lanes.
